I understand that the tuition and fee payments may be made in advance by the year, quarterly, semi-annually or monthly. I understand that tuition is the same and based on a 10 month payment plan due on the first of each month, regardless of the number of days used or the school is open.

The first tuition payment is due at the time of registration. The second tuition payment is due September 1 and can be mailed to Country Oaks School. All payments are nonrefundable. Students may not return the following school year if accounts are not cleared by the end of the previous school year owed. In the event, withdraw my child from Country Oaks School before the end of the school year I will give a **two week notice** to the directors. Tuition remains with the school.

We reserve the right to terminate service to any family enrolled when we no longer feel that the mutual best interest of your child and the school are a common goal.

I understand the ***Lateness Policy*** is as follows. There will be a charge of \$5.00 per minute assessed after the first 5 minutes after the school session ends for the day.

The State Licensing Department of California has the authority of staff without prior consent. The Department has the authority to inspect, audit and copy childcare center records upon demand during normal business hours. Records may be removed if necessary for copying. Removal of records shall be subject to requirement in Section 101217 (d).
